Ms. Ruane said that includes paving materials and it is based on what we spend every year.

Council President Lombardi explained it is a not to exceed amount, we order as we need.

Mr. Sweeney, 313 Suttons Lane, Resolution R.349-052016 asked if we are in negociation. His concern is tax abatements.

Mr. Northgrave said Clayton Block wants to start the process.
