**ORDINANCE O.2084-2020**

**EXPLANATION: AN ORDINANCE REQUIRES, UNLESS WAIVED, A REQUIREMENT THAT NEW AND MODIFIED DEVELOPMENTS INCLUDE ELECTRIC VEHICLE CHARGING STATIONS**

**WHEREAS, electric vehicles contribute to Edison Township's commitment to sustainability and are in the interest of public welfare;**

**WHEREAS, proliferation of electric charging stations encourage electric vehicle adoption;**

**WHEREAS, the Township encourages greater ownership and use of electric vehicles, the Township is amending Chapter 14 (Building and Construction) of its code;**

**NOW THEREFORE, BE IT ORDAINED, by the Municipal Council of the Township of Edison, Middlesex County, State of New Jersey as follows:**

**Section Electric Vehicle Charging Stations In New And Modified Developments Required.**

**A. DEFINITIONS**

1. Electric vehicle: A vehicle that includes (a) a battery electric vehicle; and (2) a plug-in hybrid electric vehicle

2. Electric vehicle charging station: a public or private parking space that is served by battery charging station equipment that has as its primary purpose the transfer of electric energy (by conductive or inductive means) to a battery or other energy storage device in an electric vehicle.

B. Electric vehicle charging equipment (EVCE) and electric vehicle charging stations (EVCS) shall be considered permitted accessory uses in all zoning districts. Electric vehicle charging equipment and electric vehicle charging stations shall be permitted accessory uses in all zoning districts of the Township of Edison, subject to the limitation that an electric vehicle charging station located on the property of a one- to four-family home shall not be made available for use of the general public.

C. EVCE shall be permitted in a front yard area, subject to meeting all other setback requirements.

D. Each EVCS space shall count as two required parking spaces for purposes of zoning compliance.

E. Each EVCS shall provide unobstructed access to the EVCE and shall contain signage indicating that vehicles parked in the EVCS space shall be connected to the EVCE.

F. One of the first two EVCS shall be an accessible space designed to meet the requirements for accessible parking spaces, but shall not be restricted to handicapped drivers.

G. The following requirements to provide electric vehicle charging stations shall apply to all new site plans and all site plans coming before either the Planning Board or the Board of Adjustment for substantial modifications to a previously approved preliminary or final site plan approval. A revised site plan shall be considered a substantial modification if there is any significant alteration in the layout of the buildings, public or private roadways, parking aisles or parking lots from that which was previously approved by the applicable Board.

1. All developments of three or more single-family units and condominium units that are **assigned a specific garage for the parking of their motor vehicle shall provide a 240-volt electric outlet in the garage in order to accommodate Level 2 electric vehicle charging equipment.**

2. The use groups specified below shall provide either Level 2 EVCE with a minimum output rate of 7.2 kilowatts per hour or DC fast charging stations in the common parking areas in an amount equal to 3% of the required number of parking spaces, subject to a minimum of two EVCS per location. In addition, appropriately sized electrical conduit shall be installed to additional spaces in order to allow for future expansion of the number of EVCS to 7% of the required number of parking spaces. These additional EVCS shall be installed within six months of notification by the Township that the number of plug-in electric vehicles sold in the state annually exceeds 100,000 vehicles based upon figures provided by the New Jersey Department of Environmental Protection Bureau of Mobile Sources.

(a) All apartment complexes, townhouse complexes, condominium complexes and cooperative complexes in excess of 20 residential units that do not provide individual garages for parking of vehicles.

(b) All office developments and warehouse developments in excess of 20,000 square feet of office, warehouse or other useable space.

(c) All hotels and motels in excess of 50 guest rooms.

(d) All large retail establishments referred to as "big box stores," grocery stores, and other retail establishments in excess of 10,000 square feet, as well as all gymnasiums and health clubs in excess of 10,000 square feet.

(e) All restaurants not classified as a "drive-in restaurant" in excess of 2,000 square feet.

(f) All movie theatres, roller skating rinks, commercial recreation establishments, mechanical amusement game rooms and other places of assembly.

3. The use groups specified below shall provide two EVCS in the common parking area, consisting of either DC fast charging stations or Level 2 EVCS with a minimum output rate of 15 kilowatts per hour.

(a) All automobile service stations that include a convenience store in excess of 4,000 square feet.

(b) All drive-in restaurants in excess of 2,000 square feet.

4. Each electric vehicle charging station space shall be not less than 9 feet wide or 18 feet in length. Where feasible, a vehicle charging station should comply with ADA standards.

5. Public electric vehicle charging stations are reserved for parking and charging electric vehicles only. It shall be unlawful for any person to park or leave standing a vehicle in a space designated for the charging of plug-in electric vehicles unless the vehicle is connected for charging purposes and actively charging. Electric vehicles may be parked in any space designated for public parking, subject to the restrictions that would apply to any other vehicle that would park in that space.

6. Charging station outlets and connector devices shall be no less than 36 inches and no higher than 48 inches from the ground or pavement surface where mounted, and shall contain a retraction device and/or a place to hang permanent cords and connectors a sufficient and safe distance above the ground or pavement surface. Equipment mounted on pedestals, lighting posts, or other devices shall be designated and located so as not to impede pedestrian travel or create trip hazards.

H. If any section, paragraph, subsection, clause or provision of this Ordinance shall be adjudged by the courts to be invalid, such adjudication shall apply only to the section paragraph, subsection, clause or provision so adjudicated, and the remainder of the Ordinance shall be deemed valid and effective.

I. Any ordinances or parts thereof in conflict with the provisions of this Ordinance are repealed to the extent of such conflict.

J. This Ordinance shall take effect upon passage and publication in accordance with applicable law. #11349739.1 #11450534.1

## ORDINANCE O.2085-2020

**EXPLANATION: An Ordinance authorizing the private sale of Block 922, Lot 1.A on the tax maps of the Township (more commonly known as 248 McKinley Street in the Township), an undersized land not needed for public use pursuant to *N.J.S.A. 40A:12-13*.**

**WHEREAS**, the Township of Edison (the “**Township**”) has identified certain of its property, more commonly known as Block 922, Lot 1.A on the Township tax maps (more commonly known as 248 McKinley Street in the Township) (the “**Property**”), as not needed for public use, and the Township desires to sell said Property by private sale in accordance with the Local Land and Buildings Law, *N.J.S.A. 40A:12-1 et seq.*, more particularly *N.J.S.A. 40A:12-13*; and

**WHEREAS**, the Property is a vacant lot situated in the R-BB zoning district and measures 66 feet by 123 feet; and

**WHEREAS**, there exists one (1) property holder owning land contiguous to the Property; and

**WHEREAS**, the municipal council of the Township (“**Municipal Council**”) hereby determines that the Property is less than the minimum size required for development under the Township’s Zoning Regulations (Chapter 37 of the Township’s Code of General Ordinances), and without any capital improvements thereon, and may therefore be offered for purchase to the contiguous property holder for a negotiated price, to be approved by resolution of the Municipal Council, pursuant to *N.J.S.A. 12-13(b)(5)*; and

**WHEREAS**, the use of the Property shall be restricted to one (1) single-family home constructed on the combined lots (the “**Combined Property**”).

**NOW, THEREFORE, BE IT ORDAINED** by the Municipal Council of the Township of Edison, in the County of Middlesex, State of New Jersey, as follows:

1. The aforementioned recitals are incorporated herein as though fully set forth at length.
2. The Township Clerk is authorized, subject to the terms and conditions hereafter set forth, to offer for private sale pursuant to *N.J.S.A. 40A:12-13(b)* all of the Township’s right, title and interest in the Property, at not less than fair market value thereof, to the owners of real property contiguous thereto, subject to the provision that the use be restricted to one (1) single-family home at the Combined Property.
3. This Ordinance shall be published twice in a newspaper approved for legal publications, once not less than seven (7) days prior to the second reading thereof in accordance with law applicable to the adoption of ordinances generally, and a second time within five (5) days after adoption hereof, at which time it shall also be posted on the bulletin board in the Township Municipal Building and remain so posted for at least twenty (20) days thereafter. Sworn proof of such publication(s) shall be filed by the Township Clerk with the Director of the State Division of Local Government Services in the Department of Community Affairs. A copy of this Ordinance shall also be mailed to the two owners of land contiguous to the Property.
4. The conveyance of the Property to the contiguous property owner shall be: (1) for the total parcel without the subdivision or sale of a portion thereof; (2) by quit claim deed without any covenants; (3) subject to any statement or facts which an accurate survey would show; (4) subject to all covenants, conditions, easements, liens and restrictions of record, as well as applicable ordinances of the Township; (5) without obligation of the Township to provide access, public or private, or any improvements thereon or thereto; (6) with all sales being “as is” without any representation whatever as to character, quality, condition or otherwise, contiguous property owner being deemed to have inspected the Property and waived any objections to the conditions thereon; and (7) subject to the provision that the use be restricted to one (1) single-family home at the Combined Property. The Township offers no warranty as to any environmental condition which may exist on the Property and no representation as to the Property’s development potential, and the Mayor of the Township shall execute a quitclaim deed to the contiguous property owner, subject to such additions, deletions, modifications or amendments deemed necessary by the Mayor in his discretion in consultation with counsel, which additions, deletions, modifications or amendments do not alter the substantive rights and obligations of the parties thereto.

5. The Property shall be deemed to merge and become one parcel for all purposes, including taxation and land use control, with a contiguous parcel as determined by the contiguous property owner.

6. The sale of the Property shall be for a negotiated price approved by resolution of the Municipal Council.

7. If any section, paragraph, subdivision, clause, sentence, phrase or provision of this Ordinance is declared unconstitutional or invalid by a court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance.

8. A copy of this Ordinance shall be available for public inspection at the offices of the Township Clerk.

9. This Ordinance shall take effect after twenty (20) days of its final passage by the Municipal Council, upon approval by the Mayor and publication as required by law.

**ORDINANCE O.2086-2020**

**EXPLANATION: AN ORDINANCE THAT AMENDS THE GENERAL POWERS AND DUTIES OF THE POSITION OF MAYOR TO MAKE SAID OFFICE A FULL-TIME POSITION**

**WHEREAS**, the Edison Municipal Council recognizes that the position of Mayor is presently a part-time position with a maximum salary of \$50,000.00; and

**WHEREAS**, since the establishment of the position of Mayor as a part-time position, the Township of Edison now requires a Mayor with full-time responsibilities, including, without limitation, with respect to the Township's oversight of health and public safety, finances, operation of a water utility authority, the development of a comprehensive economic development plan, and code enforcement; and

**WHEREAS**, the Edison Municipal Council hereby recommends the establishment of a fulltime Mayor's position recognizing the increased demands and responsibilities that fall on the Mayor's position; and

**WHEREAS**, the Edison Municipal Council recognizes the need to create the position of fulltime Mayor

**NOW THEREFORE, BE IT ORDAINED**, by the Municipal Council of the Township of Edison, Middlesex County, State of New Jersey as follows:

**SECTION 1:** The following sections of Chapter 2 entitled "Administration" are hereby amended as follows and that those portions of the Ordinances not set forth below shall remain unchanged:

**2.1-1**

The Mayor, as the [full-time] chief executive officer of the Township, shall have the power and duty to supervise the administration of the Charter and ordinances of the Township and the general laws applicable thereto. He or she shall have such powers of appointment and removal as are provided by Charter or general law. He or she shall have the power to appoint, with the advice and consent of the Council, to all offices where no other provision is made for such appointment; it being the intent and purpose of this provision, in order to control spending, that the Mayor shall obtain the advice of the Council and consent to appoint, hire or retain any supervisory or managerial employee whose salary, wages, and other compensation equals or exceeds fifty thousand (\$50,000.00) dollars. He or she shall assign or approve the assignment of space in public buildings and other public places for the temporary or permanent use of any department, agency, body, officer or instrumentality and shall, through the Business Administrator, control the assignment, allocation and use of furniture, equipment or other public property in the Township government. He or she may assign and reassign, transfer and retransfer, from time to time, either temporarily or permanently, any property or personnel from one function to another or from one administrative unit to another as the management of the Township government may require, subject to the express requirements of the Charter and all other applicable general laws. This section shall not, however, apply to the Council or Township

Clerk.

**[Effective January 1, 2022, the position of Mayor shall be a full time - with full time benefits and salary of one hundred thirty-five thousand dollars (\$135,000)]**

**SECTION 2.** All remaining positions and salaries of the Township's Salary Ordinance remain the same,

**SECTION 3.** All ordinances of the Township Of Edison which are inconsistent with the provisions of this Ordinance, are hereby repealed to the extent of such inconsistency,

**SECTION 4.** If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance.

**SECTION 5.** This Ordinance shall take effect immediately upon final passage and publication as required by law.

**EXPLANATION: A RESOLUTION RATIFYING EXECUTIVE ORDER 2-2020, ISSUED BY MAYOR THOMAS LANKEY ON OCTOBER 21, 2020.**

**WHEREAS**, in light of the current state of emergency, and recognizing both the need to support local businesses and the needs of residents of Edison Township (the “**Township**”) and those who work in the Township to be able to purchase food from local restaurants, Mayor Thomas Lankey issued Executive Order 1-2020 (the “**Executive Order**”); and

**WHEREAS**, pursuant to the Executive Order, effective June 1, 2020 and extending to October 31, 2020 or the cancellation of the Executive Order, whichever is earlier, existing restaurants in the Township with onsite parking are allowed to eliminate up to twenty percent (20%) of their existing onsite parking as required by existing approvals or use any other available space on the premises so as to accommodate tables for consumption of food and beverages available from such restaurants, subject to certain guidelines; and

**WHEREAS**, the Executive Order provides that an application for approval of the aforementioned temporary use must be filed with the Township zoning office (the “**Application**”), and must be approved by Township’s zoning, police, fire and health offices within seven (7) days of filing; and

**WHEREAS**, in furtherance of the Executive Order, and in an effort to assist local businesses, the Township has agreed to waive any application and/or approval fees relating its review and approval; and

**WHEREAS**, consideration of the Application includes, but is not limited to, potential for impact on neighboring properties, traffic considerations, safety of workers, patrons and others in the vicinity of the restaurant, and the ability to maintain social distance consistent with existing Executive Orders, with hours of operation limited to 8:00 A.M. to 9:00 P.M., prevailing time; and

**WHEREAS**, each restaurant submitting an Application and thereafter approved must meet all conditions established by zoning, health, fire and police, including at a minimum: a “contactless” point for ordering and delivery of food and beverages; social distancing being maintained at all times including at points for ordering and delivery of food; personal protective equipment as required by existing law or Executive Orders; wherever possible, payment for such food and beverages shall be made through electronic means; if patrons are given access to onsite restrooms, strict social distancing requirements must be established and maintained regarding such access; sanitizing materials, including hand sanitizer and sanitizing wipes, must be made available to staff and patrons; conspicuous signage must be placed at entrances and throughout the premises alerting staff and customers to the required minimum six feet of physical distance; and

**WHEREAS**, on October 21, 2020, Mayor Thomas Lankey issued Executive Order 2-2020, extending the provisions of the Executive Order through December 31, 2020; and

**WHEREAS**, the Municipal Council of the Township (the “**Municipal Council**”) hereby ratifies the issuance of Executive Order No. 2-2020 and approves the policies and procedures set forth therein.

**EXPLANATION: A RESOLUTION TEMPORARILY AMENDING THE FEE SCHEDULE AT TOWNSHIP CODE 24-4.1, REGARDING CERTAIN BEFORE/AFTER SCHOOL CHILD CARE PROGRAMS GIVEN THE COVID-19 PANDEMIC.**

**WHEREAS**, the Township of Edison (“**Township**”) is a public body corporate and politic of the State of New Jersey; and

**WHEREAS**, the Township’s Code of General Ordinances (“**Code**”) at Section 24.4.1 provides for the establishment of fees for certain before/after school child care programs, by resolution; and

**WHEREAS**, by Resolution R.694-122019 adopted on December 11, 2019, the Township had last set such fees, all prior to the onset of the COVID-19 pandemic in March of 2020; and

**WHEREAS**, due to the COVID-19 pandemic, the Township’s ABC/YAP program, which started again on October 19, 2020, will be held on a modified schedule as a result of Township schools operating on some type of hybrid schedule on school days; and

**WHEREAS**, in consequence, and in light of the ongoing pandemic, the monthly fees therefor will need to be temporarily increased or decreased, as applicable, per session of day and per number of children, pursuant to the following fee schedule:

Morning (AM) - 4 Days	First Child:	\$120	Second Child:	\$60	Monthly (10)
Afternoon (PM) - 4 Days	First Child:	\$300	Second Child:	\$150	Monthly (10)
